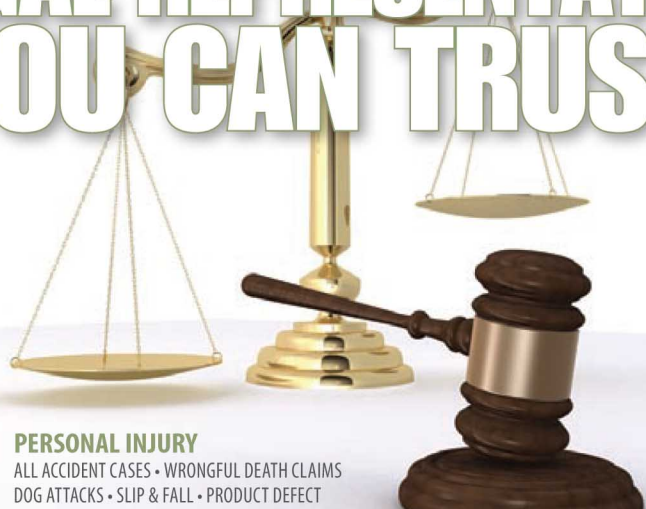

## The right steps to take in case of an accident

### • Obtain The Necessary Information

Complete this form and obtain the necessary information from the other driver and any witnesses.

### • Take Photos

Keep a digital or disposable camera in your vehicle. Take photos of the accident scene and photograph the damage to the vehicles involved in this accident.

### • Do Not Discuss Fault

Do not talk about the accident with anyone except to provide facts requested by the police or highway patrol at a scene. Only provide insurance, license and registration information.

### • Contact Us Immediately

You have the right to recover for your injuries and damages.
